

**DECLARATION OF THE RESULTS OF THE INDEPENDENT SPECIAL DISTRICT  
SELECTION COMMITTEE ELECTION FOR A REPRESENTATIVE AND ALTERNATE  
REPRESENTATIVE TO THE COUNTYWIDE RDA OVERSIGHT BOARD**

Whereas, On July 1, 2018, more than 400 redevelopment agency (RDA) oversight boards across California will be consolidated into just one oversight board per county; and

Whereas, when this occurs, each county's Independent Special District Selection Committee ("committee") will be granted the authority to appoint one special district representative and an alternate representative to that county's oversight board; and

Whereas, there are 102 independent special districts in Fresno County, and pursuant to policy action taken by Fresno LAFCo on November 8, 2017, only the 26 special districts that once included a redevelopment area within their service areas were selected to participate in the selection process for a special district representative on the consolidated RDA oversight board; and

Whereas, pursuant to Government Code (GC) sec. 56332 *et seq.*, the LAFCo executive officer gave written notice by certified mail and called for nominations for an independent special district representative to the countywide RDA oversight board; and

Whereas, pursuant to GC sec. 56332(c)(7), "For a vote on special district representation to be valid, at least a quorum of the special districts must submit valid ballots. By a majority vote of those district representatives voting on this issue, the selection committee shall either accept or deny representation;" and

Whereas, because at the close of the initial voting period on February 26, 2018, a quorum of ballots had not been received, on March 2, 2018, the LAFCo executive officer extended the voting period and sent a second notice by certified mail to the independent special districts from whom ballots had not been received; and

Whereas, at the conclusion of this extended voting period on April 16, 2018, Fresno LAFCo had received a quorum of ballots from 17 independent special districts.

Therefore, the Fresno Local Agency Formation Commission executive officer does hereby determine as follows:

**Section 1.** The canvass of selected independent special districts by the executive officer was performed in accordance with section 56332 *et seq.* of the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000, as shown on Attachment 1, attached, and the results of the election are hereby ratified, confirmed, approved, and declared.

**Section 2.** The positions to be filled by the ISDSC election were for a regular representative and an alternate representative.

**Section 3.** The names of the persons voted for as candidates for regular representative and

an alternate representative and the total number of votes received and cast in favor of each persons voted for were as follows:


