

**NOTICE OF PUBLIC HEARING
FRESNO LOCAL AGENCY FORMATION COMMISSION**

NOTICE IS HEREBY GIVEN that the Fresno Local Agency Formation Commission (LAFCo) will consider the following at a public hearing on February 14, 2018:

1. City of Clovis "Shaw-Leonard Northeast Reorganization." A proposed reorganization to annex 77.84 acres to the City of Clovis and detach from the Fresno County Fire Protection District and the Kings River Conservation District for territory located east of Leonard Avenue between Barstow and Shaw Avenues.
2. City of Fresno "Bullard-Van Ness No. 2 Reorganization" A proposed reorganization to annex 9.19 acres to the City of Fresno and detach from North Central Fire Protection District and the Kings River Conversation District for territory located west of North Van Ness Avenue both north and south of Bullard Avenue.
3. Municipal Service Review and sphere of influence update for the Riverdale Public Utility District.
4. Municipal Service Review and sphere of influence update for the Tranquillity Public Utility District.

Regarding items 1-2, if you are a landowner or registered voter within the territory of the "Shaw-Leonard Northeast Reorganization" or the "Bullard-Van Ness No. 2 Reorganization" as described above, you have protest rights and may file a written protest in opposition to the change of your property. Official LAFCo protest forms may be mailed to, delivered to the Fresno LAFCo office (address below), or presented to the LAFCo Commission before the end of the public hearing. LAFCo protest forms can be found on the Fresno LAFCo website under the application and documents tab. Pursuant to Section 56663 of the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000, unless written opposition is received before the conclusion of the commission proceedings on this proposal, the commission intends to waive protest proceedings. There is potential for extension or continuation of any previously authorized charge, fee, assessment, or tax by the local agencies. Regarding items 3-4, the commission will consider the Municipal Service Reviews (MSRs) recommendations and determinations. The commission will consider adopting the MSRs, with or without amendments, and take action pursuant to California Government Code secs. 56425 and 56430.
